BOSTON SCIENTIFIC TO ACQUIRE CAMERON HEALTH FOR \$1.35 BILLION

Austin and Houston, Texas – March 8, 2012 – PTV Sciences, a healthcare venture capital and growth equity firm, is pleased to announce that Boston Scientific has exercised its option to acquire Cameron Health in a transaction valued at up to \$1.35 billion. Cameron Health has developed the world's first and only commercially available subcutaneous implantable cardioverter defibrillator – the S-ICD® System. The S-ICD System has received CE Mark and has been commercially available in select geographies, including several major European countries, since 2009. Cameron Health received expedited review status and submitted its PMA application to the U.S. Food and Drug Administration (FDA) in December 2011. FDA approval for the S-ICD System is anticipated in the first half of 2013.
